Statutes Amendments

The Board set up a working group to undertake a comprehensive review of the Skål International Canada Statutes. The group comprised of Bill Rheaume, Jean-François Coté, Jean Pelletier and Denis Smith, undertook the task with the following goals:

- To provide definitions for the interpretation of the Statutes
- To clarify titles for the organization and committees.
- To define the scheduled Board meetings and clarify the authority of the Board.
- To clarify the timelines for key decisions affecting the organization.
- To simplify the language in the Statutes
- To clarify duties and procedures of various positions outlined within the Statutes

The Draft Statutes Amendments were approved unanimously by the SICAN Board of Directors. The next step is that the proposed Statues Amendments must be approved by Skål International to come into effect early 2015.

Membership Development Working Groups

At the spring NAASC congress, the Board undertook a strategic planning workshop and launched three working groups that focused on priority areas to help build membership.

Awareness/ Branding:

This group identified key tools and resources for members and clubs to utilize to promote Skål membership, value/ benefits and general awareness. 

Glacier Skywalk - Alberta



JASPER NATIONAL PARK, AB: The Skål Club of the Canadian Rockies literally took a step over the cliff-edge at their July 9th meeting held at the Canadian Rockies newest awesome experience, the Glacier Skywalk.

Arrive at the Columbia Icefield Glacier Discovery Centre and take in the interpretive exhibits along the cliff-edge walkway, step out on to the glass-floored observation platform 280 metres (918 feet) over the glacier formed valley while viewing the waterfalls, and surrounding glacier views.

The Canadian Museum for Human Rights (CMHR) will take you on a journey of inspiration unlike anything you've experienced before. From the moment you enter through its massive stone roots, to the time you emerge in its light-filled Tower of Hope, you will be moved by the power of human rights. Canada's newest national museum rises from the Prairie earth in Winnipeg at The Forks, where the Red and Assiniboine rivers meet.
